Installing ICEDirect -This will have to be a complete new full installation if you haven't downloaded and installed at least ICE 17.0 P4 yet.

ICEDirect is a collection of application interfaces that provide access to the Integrity Controls Environment through the internet using a browser-based interface, The Web Edition. This is an SMP Installation and for ICEDirect it will be required to do a new full download and installation. After downloading the DISKET File you will run the INSTALL Job and then run the following jobs inside of the IFOHLQ.INSTLIB.

Then you will have to supply support@newera.com with a D M=CPU as ICEDirect will require a new set of License Keys.

After running all the above jobs, you will update the Member NEZWEB00 in the IFOHLQ.PARMLIB Dataset with the information needed.
